

Biggest Little Furry Convention - Parental Permission & Release form

Biggest Little Furry Convention (BLFC) is an annual convention celebrating the artist expressions of fans of anthropomorphic artwork. No special concessions are being made for the attendance of minors, but they are welcome to attend, subject to the additional rules below.

- BLFC is not a supervised environment, and is not responsible for the conduct of attendees. Parent understands that their child is in attendance at his or her own risk. Parent agrees to indemnify and hold harmless both BLFC and the Grand Sierra Resort, and both companies' officers, directors, agents, and employees with respect to all activities associated with, or any damages arising out of BLFC and from any cause of action of any nature arising from their child's participation in BLFC.
- BLFC is not acting *in loco parentis* (in place of a parent) for the attending minor. Parent understands that they are responsible for the care, safety, and conduct of their child, whether or not they are attending with their child.
- Parent understands that the minor is expected to follow the convention policies, and the parent is solely responsible for policy violations on the part of the minor. Furthermore, both the minor and an accompanying parent can be ejected together from the convention resulting from policy violations by *either* party. - Minors under the age of 16 on May 3, 2013 can attend with this signed form (no notary necessary), when accompanied by a parent at all times. A free "supervised minor" badge will be supplied with the parent's paid badge.
- Minors between the ages of 16 and 18 on May 3, 2013 can attend without parental supervision by supplying this signed and notarized form, and an ID showing proof of age. *The minor must bring the original signed copy of this form.*
